- We documented another PJI-backed signature gatherer committing election fraud, by falsely claiming that trans protections for children led to rape and molestation.
- We documented the anti-trans propaganda.
- We documented what known hate groups were saying about trans kids.

Here again, we caught anti-trans signature gatherers lying to the public in order to scare them into supporting discrimination against trans kids:

An advocate in California snapped this photo while coming out of a Stater Brothers store. The signs falsely asserts that trans protections = co-ed restrooms. This is a violation of California Election Code § 18600 as it is a fraudulent representation of the facts. Note that they’re also scaring people into giving them money.

To be clear: AB 1266 never asserts that cis boys get to hang out in the girl’s restroom. That’s a lie. Let’s also be clear that after a decade of having California-style policy in place all over the country - even in places like Houston, Dallas, El Paso, San Antonio Texas, the best these anti-trans groups can do is lie in order to pretend that these policies are problematic.
